# CSC February Unrated Fee Schedule

## **Fees**

- Classes: \$35 for non prize money classes/\$40 for the Stake/\$50 for Gamblers
- If fewer than 6 entries in Prize Money classes, Prize Money will be reduced and entry fee reduced accordingly
- EMT Fee: \$35 per entry
- Media Fee: \$40 per entry, includes unlimited low res digital downloads from Vince LeMaster photography and Buy Two Get Third 50% off from Zoey Berg Social Video
- Office Fee: \$50 per entry
- Stall Fee: \$200 Thursday - Sunday
  - \$150 Friday - Sunday
  - \$125 overnight Friday/Saturday or Saturday/Sunday
  - \$100 Single Day
  - \$25 Late Fee per stall for stalls booked after Feb 11
  - \$75 per stall for stalls canceled after Feb 15, substitutions allowed
- Shavings (minimum 4): \$14 per bag ordered before Feb 15, \$15 after (email for facility's requirements if per veterinary horse needs different bedding) Bags can not be returned. So if unused, they go home with you.
- Ticketed Schooling available Friday time TBA \$25
  - This will be the only guaranteed jump schooling.
  - Hacking Only in the mornings.
  - Schooling between heights will be schedule dependent and not guaranteed.
- Non Showing horses pay EMT, Office, and Applicable Stall Fees
- Trailer In: \$75 per day
- Checks, credit cards\*, cash, Venmo, Zelle, and PayPal accepted. \*2% fee. Returned checks will be charged \$50 or 5% of the check, whichever is greater.

Trainer Sale Horses: Horses owned by trainer or trainer partnership and ridden only by the trainer will have the office and media fee waived.

Sale Horses: Horses with a Blue Dot sticker on the number are for sale. Stop by the office to pick up a Blue Dot.



## **Regulations**

- Unjudged rounds will be allowed at the end of each class
- Prize money will be 50%, 30%, 20%
- Horse/Rider combination must enter Stake/GC at highest height horse/rider combination entered
- Horse/Rider combination must be entered in at least one class other than Stake and/or Gamblers Choice
- Conventional tack required. For unconventional tack, ruling of judge/mgmt will stand. If you aren't sure, ask in the office.
- Show management may change the schedule, combine, or remove classes at management discretion
- Stake and GC classes with fewer than 6 may have decreased prize money, entry fees will be adjusted accordingly
- Champion and Reserve will be awarded in each Jr/Am division with at least 3 entries in each class (2b, Speed, and Stake make the division) Gamblers Choice results will be used to break ties
- ASTM certified helmets required
- Judge/mgmt reserves the right to eliminate horse and/or riders for unsafe riding
- Physical or verbal abuse of anyone on grounds will not be tolerated and riders may be eliminated from competition with no refund.
- USEF/USHJA Schooling rules apply



## **Ticket Program**

- Tickets are given for each placing: 10, 6, 4, 2, 1, 1
- Tickets are like cash, they may not be replaced but may be combined with other exhibitors, given to other exhibitors, exchanged at this show for smaller prizes or saved and added to future shows for larger prizes
- Prizes include items such as: sticker books, hoof picks, ear pom poms, boot polish, halters, saddle pads, vests, jackets, shirts, boot socks, gloves, crops, night lights, stuffed animals, pajamas, horse coolers, custom horse coolers, custom scrims, custom tack room drapes, custom tack trunk covers.



## Biosecurity

### **Required**

1. A current negative Coggins test
2. Vaccination records showing date of vaccination against Equine Influenza and EHV 1 & 4 (Booster within 180 Days)
3. Health certificate dated by a licensed veterinarian within 30 days of arriving at the venue
4. Current WNV, EEE, WEE, Tetanus and Rabies vaccinations are strongly recommended.

Horses may not unload until paperwork is approved.

## Colorado Show Circuit (CSC) & The Ranch Events Complex (TREC), WAIVER AND HOLD HARM-LESS AGREEMENT

Every entry at a recognized competition shall constitute an agreement and affirmation that all participants (which include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse), For themselves, their principles, representatives, employees and agents: (1) Shall be subject to the constitution and rules of CSC, TREC, and the local rules of the competition; (2) Represent that every horse, rider, driver, and handler is eligible as entered; (3) Agree to be bound by the constitution and rules of CSC, TREC, and of the competition, and will accept as final the decision of CSC and TREC on any question arising under said rules, and agree to hold the competition, CSC, TREC, and their officials, directors and employees harmless for any action taken; (4) Agree that as a condition of and in consideration of acceptance of entry, they authorize CSC, TREC, and/or the competition management to market, transfer, assign or otherwise make any use of any photographs, likenesses, films, broadcast, cablecasts, audiotapes, or videotapes taken of the horses(s) and participant(s) while on the grounds, incident to, or in transit between the stabling facility and the event site, in any way they see fit for the promotion, coverage or benefit of the event, sport, CSC or TREC, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service, and hereby expressly and irrevocably waive and release any rights in connection with such, including any claim to invasion of privacy, right of publicity, or to misappropriation; and (5) Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to hold CSC, TREC, and the competition and their officials, directors, employees and agent harmless from and against all claims including claims based on negligence, breach of contract, strict liability and/or otherwise for any injury or loss suffered during or in connection with the competition, officials, directors, employees or agents of CSC, TREC, or competition. The construction and application of CSC and TREC rules are governed by the laws of the State of Colorado, and any action instituted against CSC and/or TREC must be filed in the State of Colorado.

UNDER COLORADO LAW, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES, PURSUANT TO SECTION 13-21-119 COLORADO REVISED STATUTES.

I hereby agree to release, indemnify and hold harmless CSC, TREC, officers, directors, agents and volunteers from and against any and all loss, liability or damage arising from or because of, or in connection with, participation in this competition or related activities. I also hereby agree to release, indemnify and hold harmless the show management, show committee and members, officers, directors, agents, and volunteers from and against any and all loss, liability or damage.
