## Rules and Regulations

USEF MEMBERSHIP STATEMENT Life, Senior Active and JuniorActive members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrilled classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

FEDERATION ENTRY AGREEMENT By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of Colorado. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harm- less the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation, and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the compe- tition for promotion, coverage or benefit of the competition, sport, or. The Federation. Those likenesses shall not be used to advertise a product that they may not be used in such as way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and applica- tion of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4

## Rules and Regulations

**USHJA HORSE REGISTRATION** All horses competing in federation non-breed restricted competitions must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms. Applications for Registration Numbers can be completed online or using the Horse Registration application form. See HU101.1 and JP100.2 of the USEF Rule Book. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license to operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hoverboards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**ENTRIES:** Competitors are encouraged to use the free app, HorseSpot.com and choose Colorado Show Circuit or CoShows.horsespot.com. It can also be accessed through the Stall Request site, CoShows.stallinfo.net. You may also email entries to coloradoshowcircuit@gmail.com. Scanned PDFs preferred but photographs will be accepted. Mail to: Colorado Show Circuit 7686 Nuthatch Way, Parker CO 80134. Entry blanks will be accepted ONLY when signed by the owner or exhibitor's agent, trainer, and rider. Be sure to include the USEF Membership number of your trainer, rider and owner on the entry form. No numbers will be released until proper credentials and all signatures are in order.

**Per USEF, BACK NUMBERS MUST BE WORN AT ALL TIMES THAT A HORSE IS OUT OF ITS STALL.**

All exhibitors in Amateur sections must present their Amateur certification at the office before numbers will be released. Non member fees will be \$45 each to both USEF and USHJA.



## Rules and Regulations

**MEASUREMENTS** All exhibitors in the Junior Hunter sections must present their measurement cards at the office before numbers will be released. All Juniors Hunters who do not possess a current measurement card will be measured with the steward by appointment. If a measurement is needed, please notify the horse show by emailing ColoradoShowCircuit@gmail.com by Monday, March 10th so that arrangements may be made with the vet.

Management reserves the right to combine or cancel any classes deemed necessary and the right to refuse any entry in accordance with GR914. Colorado Show Circuit, the owner, their officials and employees will not be responsible for any accident or loss which may occur to an exhibitor, spectator, guest, rider, groom, attendant, or other employee, animal or equipment at the show.

**\*\*THIS WILL BE A CONDITIONS OF ENTRY TO THE SHOW AND SHOW GROUNDS\*\***

- + A processing fee of \$50 plus collection fees will be made for any non-negotiable checks
- + Venmo, checks, PayPal, or Credit Cards are all approved methods of payment
- + All riders must wear ASTM Certified protective headgear while mounted
- + No alterations are to be made to permanent stabling or other facilities by exhibitors
- + No smoking is permitted inside the barn
- + Prize money exceeding entry fees will be distributed within 30 days. \$4975 offered, \$750 guaranteed.
- + Dogs must be leashed at all times. Per USEF Rule 1301.6 dogs are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards.

### **REFUNDS**

Refunds will be given, for all but stall fees, in the case of a vet note or if a barn brings an alternate horse/rider combination as a substitution or if the stall can be resold. Once a horse/rider has arrived on property refunds for grounds/stall/office/and medic will not be given. Stall fees are non-refundable after booking unless an alternate horse is used.

### **SAFE SPORT STATEMENT**

All USEF Life and Senior Active member, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ## Rules and Regulations

USEF GR902.1 EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATION OF THE CURRENT USEF RULEBOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

Warm Ups: Warm up rounds may not be done back to back with medal class rounds. The Warm Up card per height must be closed prior to the start of each medal. The last horses 3 horses in the warm up rounds may not be the first 3 in the medals. If there are 3, then the order of the medal must match the order of the warm up.

Fences: spreads may not exceed height.

### Conduct

Please remember that you are in front of the general public and children and should set a good example of horsemanship and sportsmanship at all times. Management reserves the right to remove anyone from grounds that the committee feels is behaving in an unsportsmanlike manner. Physical or verbal abuse of anyone or animal on the showgrounds will not be tolerated.

Please consider your horse's long term future and well being when reviewing your class count.

Pony Zamboni is sponsoring a sportsmanship award, please nominate exhibitors, family members, grooms, or trainers who display the traits of a good sportsman during the competition by participating in acts that benefit other exhibitors or serve as examples of good horsemanship.

## General Specifications

**Tickets:** Tickets equal to USEF Points will be given out in classes that do not give prize money. Tickets may be given to another person, turned in for prizes, or saved and combined with past and future CSC competitions for bigger prizes such as custom coolers (your colors and logo), custom tack trunks.

**Lunging:** The entire warm up area will be available for lunging and hacking between end of show each day and 7am the next morning. After that a smaller portion will be blocked off for lunging.

**Open Schooling:** will be available from 10am - 5pm on Thursday. No additional show arena jumping will be available. Hacking will be available in the show arena from 6am - 7:30am each morning. All horses will be assessed a \$20 schooling fee. In the event that the arena becomes crowded management reserves the right to enforce a 5 horse in the arena limit with a one out one in policy.

**Arena Dimensions** are 110 x 240 with sand/dirt blend. Warm up arena is 90 x 300 sand/dirt blend.

**Stalls:** 10 x 10 with doors and mats. Stalls may not be reconfigured as double stalls. Stalls booked at [CoShows.stallinfo.net](http://CoShows.stallinfo.net)

**Back Numbers:** All horses must be accompanied by a back number at all times that they are out of the stall or away from the trailer.

**USHJA Horse Registration:** All competing horses must have a Registration number from USHJA.

**Dividing/Combining Divisions:** Management reserves the right to divide or combine divisions in accordance with USEF specs.

**Food Service:** Soda, Gatorade, Water, and snacks will be available for purchase at the show office beginning at 7am until the conclusion of each show day. Food trucks will be available outside the building from 11 - 3 Friday.

**Show Veterinarian and Show Farrier:** contact information will be posted in the barns and outside the show office. Sharps containers will be available at the end of alternating aisles.

**Trainer Splits:** Please organize trainer splits with the office by Friday afternoon or before clients begin checking out. If a client checks out before splits have been applied, trainer will be responsible for the remaining balance.

**Trainer Horse:** A trainer project horse (owned solely by trainer or in a partnership with the trainer) ridden only by the trainer will be exempt from the Office/Grounds fee.

**Opportunity Class Only:** Horses and riders that are doing ONLY classes with Opportunity in the name are exempt from USEF and USHJA membership fees. If the horse or rider is entered in ANY other class, including a warm up, this exemption does not apply. In addition to the waived membership, CSC will waive that horse's office/grounds fee.

**Sale Horses:** Horses with a blue dot sticker on their back numbers are for sale. Stop by the office to grab a blue dot to advertise your horse.

## FEES

**Office/Grounds Fee:** \$60 assessed to each back number. Trainer horses are exempt from this fee.

**Trailer In:** A trailer in fee of \$90 will be assessed to any horse that does not have a stall.

**Medic:** \$25 assessed to each entry.

**Gate Add Fee:** A fee of \$25 will be added to each entry that is found on the judges' card that was not added in the office prior to the start of the class.

**Individual Class/Division Fees:** found in class/division descriptions. Any class without a listed fee will be \$40.

**Governing Body Fees:** Each horse will be charged a USEF Fee of \$25 per competition (\$15 Drugs and Medications, \$10 USEF), a \$7 fee for USHJA Zone fees. Any non-member must purchase a \$45 show pass fee from USEF.org and a \$45 show pass fee from USHJA.org.

### **Stall Fees:**

Thursday - Sunday: \$250

Single Day: 6am - 6pm, \$125

Work Off Trailer: \$90

Stalls cancelled after Feb 16 will be responsible for \$150 for a weekend stall or \$100 for a day stall. Substitutions are allowed.

**Shavings:** (min required, 4 bags per stall) Available at \$14 per bag if ordered by February 11, after that they will be available at \$16 per bag. If a horse has a veterinary excuse for outside shavings, please contact show management at ColoradoShowCircuit@gmail.com so we can get you the facility's requirements for that circumstance. Unused shavings may not be returned.

**Media Fee:** All entries will be charged \$40 for unlimited low res digital photos. Additional specials will be available to exhibitors for edited, hard copy photos. All from Vince LeMaster Photography and a Buy Two Get One Free Zoey Berg Social video. Trainer horses are exempt from this fee.

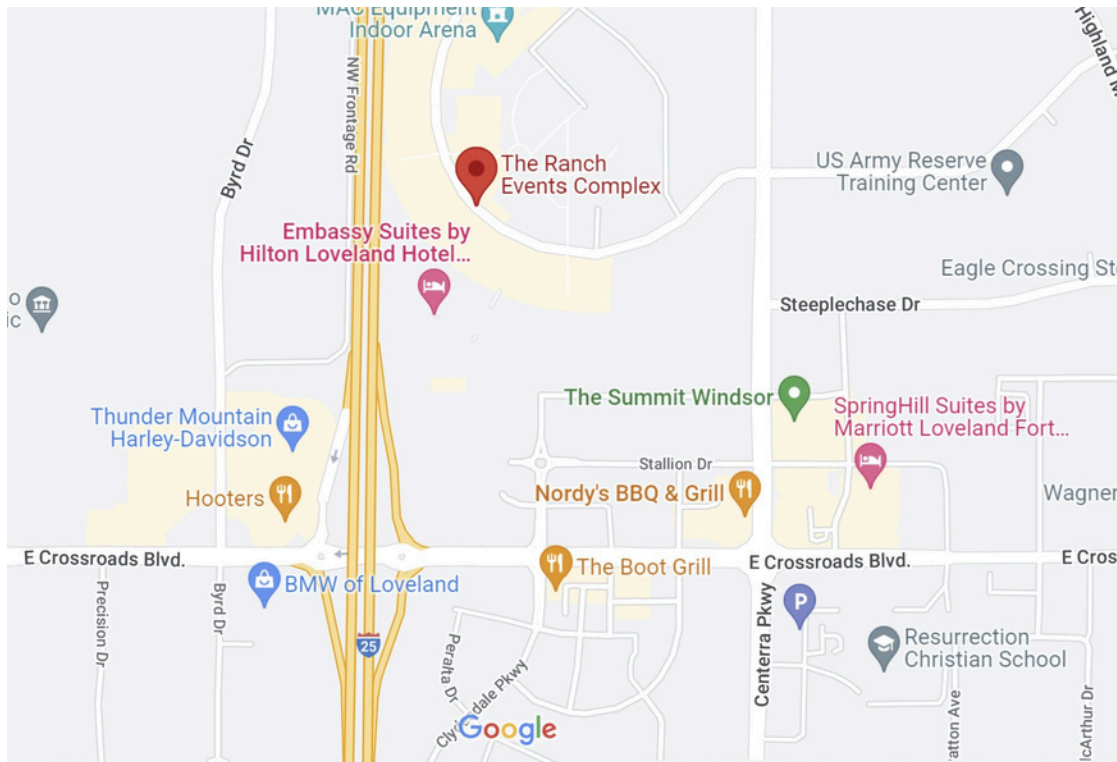

2. Vaccination records showing date of vaccination against Equine Influenza and EHV 1 & 4 (Booster within 180 Days)
3. Health certificate dated by a licensed veterinarian within 30 days of arriving at the venue
4. Current WNV, EEE, WEE, Tetanus and Rabies vaccinations are strongly recommended.

Horses may not unload until paperwork is approved.

## Hunter Classes

All hunter classes will be judged on performance and soundness. A Champion and Reserve CHampion ribbon will be given in each Hunter section that includes an under saddle class. THree classes with at least three completions must be held in order to award champions. Championships will be broken by highest over fences points.
