MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

Motor Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hoverboards, and single-wheeled scooters is prohibited on competition grounds. Rules and Regulations

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE USEF RULES AND SPECIFICATION WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. ENTRY FEES ARE \$25 PER CLASS UNLESS OTHERWISE NOTED

- Pre entries will be accepted until 12pm the two days before the horse show via email and RingRadar.com, after that post entry fees will apply.
- Entries received after 12 noon 2 days before the show will be charged a \$25 post entry fee.
- SCHOOLING will be permitted only in areas provided. All horses/ponies not showing will be charged \$75.00 for schooling.
- All horses/ponies must school with a back number.
- A \$35.00 fee will be charged to all entries for office fees and \$25 grounds /EMT fee. A \$2.00 Number fee and \$5.00 USHJA fee will be charged to all entries.
- A valid form of payment must be on file with the show office in order for back numbers to be issued. In addition to Checks, Venmo, Credit Card and Paypal are accepted as payment; a 4% convenience fee will be assessed if paypal or credit card option is utilized. All entries not paid at the horse show will incur a \$50.00 late payment fee.
- There will be a \$50.00 fee for returned checks.
- MANAGEMENT reserves the right to cancel, combine, or divide classes at their discretion.
- GARDEN GROVE HORSE SHOW, MONMOUTH COUNTY PARK SYSTEM, ITS OWNER OR THOSE CONNECTED WITH THE SHOW WILL NOT BE RESPONSIBLE FOR DAMAGE, INJURY OR LOSS TO ANY PERSON, ANIMAL OR PROPERTY OF EXHIBITOR OR SPECTATORS.
- ASTM/SEI certified headgear is required at all times when mounted.
- Jump order will be established at the gate with the starter.
- Hunter courses may be judged on performance, soundness, and manners. They may include gates, coops, walls, brushes, oxers, panels and combinations.
- For all sanctioned classes other than USEF pointed classes such as PEL/NJPHA/NJHSA/M&S, horse and rider combination must enter at least one other class at the same show.
- ALL ties other than first will remain tied.
- All measurements will be the responsibility of the horse show when made by appt. Between 7:00 - 8:00 a.m. anytime after will be available at the exhibitor's expense.
- Ring One 179' x 163' all weather footing, Ring Two 154' x 160' all weather footing, Ring Three 136' x 208' all weather footing.
- All pets must be kept on a leash at all times.
- Sharps containers will be located at the show office
- No Alcohol is permitted on the Showgrounds
- Horse/Rider combination must complete at 2 horse shows in their respective division to be eligible for Series Awards.
- Horse/Rider combination must have an active Garden Grove Horse Show Membership to be eligible for Series Awards.
- **All trainers/coaches must be active USEF Members and up to date on Safe Sport Trainings. Riders/Horses DO NOT need to be active competing USEF members.**

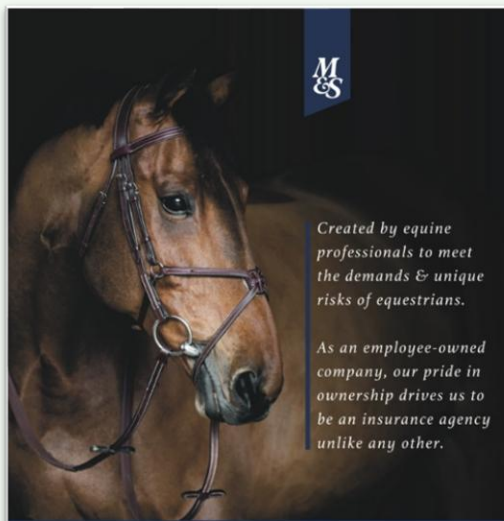
