RULES AND REGULATIONS FOR HORSE SHOW

1. Every class offered herein is covered by the rules and specifications of the current USEF rulebook and will be judged in accordance therewith.
2. To be eligible for an award in any LIPHA section, the horse, pony or rider must have shown in their respective division in at least 6 shows.
3. ENTRIES CLOSE 48 HOURS PRIOR TO THE SHOW. NO PHONE ENTRIES ACCEPTED. Post Entry fee is \$50.
4. NO NUMBERS WILL BE GIVEN OUT WITHOUT FEES PAID FOR IN FULL AND ENTRY BLANK SIGNED BY BOTH THE EXHIBITOR AND/OR AUTHORIZED AGENT AND TRAINER. THIS RULE WILL BE STRICTLY ENFORCED.
5. All exhibitors in the Pony and Junior Hunter Sections must present their measurement cards at the show office prior to the number being picked up to speed up processing. You may send a photocopy of your card to the secretary.
6. Horse/Pony Measurements are by appointment. Please contact show management no less than 24 hours prior to the show to arrange to have VET there prior to class. Horses/Ponies being measured must be entered in show on day of measurement.
7. Classes with insufficient entries may be cancelled or be combined with another division.
8. Should any question or dispute arise that is not provided for in these rules, the same shall be referred to Show Management, WHOSE DECISION WILL BE FINAL.
9. Prize money will be deducted from your total fees. Entry fee is \$35.00 per class, unless otherwise noted. Post Entry Fee is \$50.00 per show (Entry must be received 48 hours prior to show).
10. Incomplete entries (without classes or USEF/USHJA numbers info) will be considered late and be subject to post entry fee of \$50.00.
11. Division Championships: Ribbon/Prize will be awarded based on the USEF Rules in all Hunter and Jumper Divisions Points will be awarded as follows: Jumper - 10, 6, 4, 3, 2, 1 ½, 1, ½, Hunter - 10, 6, 4, 2, 1 ½, 1, ½, Equitation - 10, 6, 4, 3, 2, 1 ½, 1, ½. In the case of equal points, the rider with the most points over fences will be declared champion. In the event there is still a tie, the rider with the most points in the first class over fences will be declared champion.
12. Riders who have conflicts must see the Gate person at each ring so that the necessary adjustments may be made. Trainer conflicts will not be honored.
13. The committee reserves the right to add to or vary the list of judges if necessary.
14. A sharp container is located in the Secretary's stand.
15. Checks returned unpaid will be subject to a \$50 service charge and any future entries will be on a cash basis only.
16. Our Show Scratch Fee is \$50. If the rider scratches after schooling, rider will also pay schooling fee.
17. Schooling fee is \$25 per session. For the comfort and safety of our exhibitors and their horses during schooling, rings will be carefully monitored. When entering the ring, rider must wear back number to school. Ground fee plus \$25 fee per schooling will be charged.
18. Schooling sessions between divisions will be limited to 10 minutes. Trainers are encouraged to school client's horses in the rings in the am prior to start of competition.
19. It is the responsibility of the exhibitor to have current membership for all types of classes they are entering. Any fines incurred by the horse show for incorrect memberships will be the responsibility of the exhibitor. Individuals unable to present proof of membership for USEF classes, member must show USEF show pass - click: [Show Pass | US Equestrian \(usef.org\)](#)
20. ATSM approved protective head gear must be worn when riding anywhere on the grounds. Anyone riding on the grounds must have a signed entry blank in the office.
21. Stabling not available on show grounds.

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement, to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

GR1301.7 Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) lead line; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

From North Shore

Go east on Route 347. Proceed from this point approximately 6 miles. Turn right onto Rocky Point Rd (CR-21), go about 3 miles to farm on right. Sign says Island Hills Stable.

From South Shore

Take Sunrise Highway to CR-101/Exit 55 toward Patchogue/Yaphank, then head north onto CR-101/Sills Rd. Stay straight (road turns into Patchogue/Yaphank Rd). Follow around bend

and lake as it turns into Yaphank Middle Island Rd/CR21. Once you cross over Route 25 the road becomes Rocky Point Rd, farm will be 1.4 miles on left. Sign says Island Hills Stable.

From LIE Heading West

Take LIE to exit 66 CR-101/Sills Rd. Make a right and head north on CR-101/Sills Rd. Stay straight (road turns into Patchogue/Yaphank Rd). Follow around bend and lake as it turns into Yaphank Middle Island Rd/CR-21. Once you cross over Route 25 the road becomes Rocky Point Rd, farm will be 1.4 miles on left. Sign says Island Hills Stable.

From LIE Heading East

Take LIE to exit 66 CR-101/Sills Rd. Make a left and head north on CR-101/Sills Rd. Stay straight (road turns into Patchogue/Yaphank Rd). Follow around bend and lake as it turns into Yaphank Middle Island Rd/CR-21. Once you cross over Route 25 the road becomes Rocky Point Rd, farm will be 1.4 miles on left. Sign says Island Hills Stable.

I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage, or benefit of the Competition, sport, or the Federation. Horse likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules and governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.



WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK. Under the laws New York, an equine activity sponsor or equine professional may not be liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities. See SECTION 18-301-303 OF THE GENERAL OBLIGATIONS LAW.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.

By signing below, that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time, as well as all terms and provisions of this Prize List. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.

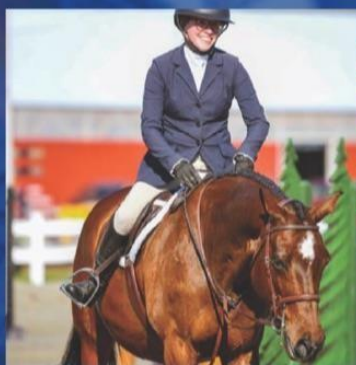

LIPHA BEGINNER EQUITATION:

Open to junior riders who have not reached their 18th birthday and who have not shown in any class where jumping a course of jumps. Once a rider competes in the mini short stirrup or above, they are no longer eligible for beginner equitation.

LIPHA MINI SHORT STIRRUP:

Open to junior riders who have not reached their 18th birthday. Riders who compete in the short stirrup or above are no longer eligible for the mini short stirrup. Riders to jump a course of cross rails not to exceed 18" which will not include a change of direction on course.

LIPHA SHORT STIRRUP:

A rider who enters and shows in the Short Stirrup Division (Equitation or Hunter) shall not be eligible to enter any other section or division at that show. Riders must be age 12 or under as of December 1 of the current show year. In order to split the section 8 are needed, at least 3 in each section. Section to be split by age, 9 & Under and 10-12. Permissible test for the Short Stirrup Courses for all short stirrup classes must consist of at least six (6) cross rails not to exceed 18". In the Short Stirrup Hunter Section, courses must contain 1 change of direction. Equitation will be split by age for year-end awards if there are at least 3 entries in each group.

LIPHA LOW CHILDREN/ADULT HUNTERS:

Open to juniors & adults. Two sections must be offered: Ponies and Horses. If there are less than 3 entries in either the Pony section or the Horse section, both sections must be combined. Ponies to jump 2' and horses to jump 2'6". Riders may not cross enter the Children's or Adult Amateur Hunter division or any class/section where fences exceed 2'9" (Exception: 3'0" Equitation). If entries warrant, the division may be split for year end awards.

LIPHA LOW CHILDREN HORSE/ADULT EQUITATION:

Open to junior & adult exhibitors. Fences 2'. Three sections must be offered: Ponies, Horses and Adults. Riders may not cross enter into any other equitation class or hunter class where fences exceed 2'6". Divisions may be split as entries warrant for year end awards.

LIPHA CHILDREN HUNTER HORSE:

Open to all riders not competing in class where height exceeds 2'3" for 2'0 riders or 2'6" for 2'3" riders. LIPHA Low Hunter 2'6: No restrictions as to horse/pony or rider or cross entering. At the discretion of Show Management, a Handy Hunter Class may be offered in this division. USEF specs apply.

LIPHA PRE-MINI 2'6" MEDAL/MEDIUM ADULT MEDAL EQUITATION:

Division makes up a combination of Medal, Maclay, and PHA equitation classes that are a modified version of the courses used in the National Medal Classes. Exhibitors must have not won three (3) blue ribbons in any 3' or higher equitation class. Riders may not compete in any classes exceeding 2'6" at the same show that they compete in the Pre-Mini or Medium Adult Division. Fences not to exceed 2'6".

LIPHA ROSS REISNER MINI MEDAL:

Division makes up a combination of Medal, Maclay, and PHA equitation classes that are a modified version of the courses used in the National Medal Classes (3'6" and 3' classes). Fences at 3'0".

LIPHA HIGH ADULT MEDAL:

Division makes up combination of Medal, Maclay, and PHA equitation classes that are a modified version of the courses used in the National Medal Classes (3'6" and 3' classes). Fences at 3'0". May be combined with Ross Reisner Mini Medal if there are fewer than 3 entries at the horse show. For LIPHA year-end awards, this class will be combined with Ross Reisner Mini Medal unless there are at least three qualified adult riders.

COMBINING JUMPER SECTIONS AT SHOWS:

If there are fewer than 3 entries in any section, the sections may be combined at management's discretion allowing each section to compete at their respective height to fill the division. Points will be applied for year-end awards based on the respective height. If sections are combined, a horse can only compete at one height in each class.

All Jumper classes are open to horses and ponies.

LIPHA LOW JUMPERS: Fences 2'6"

LIPHA JUMPERS: Fences 0.95m to 1.00m (3' to 3'3"). Open to All riders
