Entries: Pre-entry closing date is August 27, 2025. All entries will be online at NMStateFair.Horsespot.net There are no post entry fees for online entries. Payment by check or credit card will not be required until check-in. Pre-entries are encouraged for expedited gate admissions and preferred stabling assignments. Cattle, Dressage and Western Dressage will require entries by Closing date of August 27, 2025. All Entries pay Office fee per Exhibitor/Horse as designated by each show's specified rules and entry requirements. Pre-ordered shavings by closing date will be at your stalls on arrival. Entry confirmation will be sent to email on entry form for initial gate 6 access at move-in. PRE-ENTRIES online are ENCOURAGED! No need to print entry form. Any signature pages can be completed at check-in. All entry requirements can be done with the new online platform!

Payment: Checks payable to EXPO NM or valid credit card required upon show completion. You may send entry by email without payment to the secretary or go completely through the online entry platform with Horse Spot.net. You do not need to use a credit card to confirm your online entry! To obtain back number, each horse will need to submit health certificate (dated within 30 days), leave an open check or credit card form, and liability waiver for all participants. Adult signature is required for minors. Bad checks and declined credit cards incur \$50/occurrence fee.

Check-In: All entries will be assigned stall or designated parking for trailer-in when they enter Gate 6. There is a Horse Hut office attendant that will greet you and show you your stall area. Please be prepared with your confirmation of entry and health papers to proceed to unload. When your horses are settled, the office in the indoor horse complex will check you in. Please refer to the NMLB website for further requirements by state. On Site/post entries are accepted for all shows EXCEPT Cattle, Dressage, and Western Dressage.

Check-Out: Health papers will be returned upon closing of account and proper payment completed at the end of the show. Gate 6 Horse Hut attendants will verify your health papers upon departure. The health and safety of your horses is our top priority, and these requirements will be enforced.

Office: Will be open 1 hour before the start of the competition daily and stay open at least 1 hour after final class. Check-in for groups of 6 or more are advised to contact the secretary for a time slot. Please call 505-803-3228.

Scratched/Added classes: Entries will only be charged for classes they participate in and may add or scratch during the show through the HorseSpot.net platform with no penalty.

Feed & Bedding: Shavings and feed may be pre-ordered on entry form for \$11/bag. Orders for shavings can be added to your pre-entry or purchased through the show office or HorseSpot.net. No outside shavings are allowed without veterinary certification of medical need.

Arenas: Indoor arena 117' x 250'. Outdoor arenas 125; x 264'. Footing is sandy loam in all arenas.

Stall Assignments: Pre-entered horses may request stall areas. We cannot guarantee those stalls will be available. Groups of horses or trainers should submit entries together to be stabled in a group with stall reservation form. Stalls may be occupied after 5pm the night before the event and must be vacated at the end of the day of show entered. 1 Horse Stall for one day is included for each entry. Only one animal per stall. Tack rooms must be added to a horse's entry to reserve at the rate of \$25/night or day and not included with \$30 base office fee. The stall chart will be available at the Gate 6 entry Horse Hut. **NEW MEXICO STATE FAIRGROUNDS IS NOT RESPONSIBLE FOR ANY ITEMS LEFT UNATTENDED.**

Parking: Designated unloading zones have a 45-minute limit. There is no parking in barn aisles or leaving trailers unhooked for any reason. Vehicle parking for exhibitors will be available, on a limited basis, in the Gate 6 area with parking pass. Each Horse entered will include 1 parking pass and 2 admission tickets. Any additional parking passes and/or admissions passes

will need to be purchased at the horse show office during check-in. Support vehicles during set up will need to purchase additional passes for show days. The entry for horse trailers and exhibitors is Gate 6 at the northwest corner of the grounds. This is south of Lomas on the east side on San Pedro (across from McDonald's). Gate 6 is open from 6am to 9pm daily. After hours arrivals/departures use Gate 3, which is further south on San Pedro at the Copper stop light.

Trailer Parking: There is no on-site (unhooked) trailer parking. The armory located at 600 Wyoming Blvd., Albuquerque, NM 87123 is a secure site for trailers to be unhooked while you show. Parking in the lot at gate 6 is for passenger vehicles only. You may obtain parking passes for the off-site parking at the horse show office. Maps are available at show office. Limited parking is available for day trip haul-in for shows in the far East Roping arena.

Prize List Corrections/Changes: The NM state Fair reserves to itself the final and absolute right to interpret these Competition Requirements, to fairly and impartially settle, determine all matters, questions and differences in regard thereto, or otherwise arising out of or connected with or incident to the Show, and the right to amend or add to these Competition Requirements as its judgments may determine. The NM State Fair reserves the right to cancel events or change scheduling if determined necessary. See each division for any specific or special Competition Requirements.

Dogs: No dogs are allowed in competition arenas or warm-up areas.

Motorized Vehicles: No golf carts or private motorized vehicles are allowed.

Protective Headgear: Any Exhibitor may wear protective headgear in any division or class without penalty from the judge. USEF strongly encourages all Exhibitors to wear protective headgear. It is the responsibility of the Exhibitor, parent, guardian, or trainer of the junior exhibitor to see that the headgear worn complies with safety standards and is properly fitted and in good condition.

Prize Money & Awards: Payouts will be issued to the exhibitor of the class within 30 days. W-9 and full account payment required for all entries. Buckles/Awards will be awarded onsite at the conclusion of each show. **Winners must pick up all awards or they will be forfeited and awarded to the next eligible winner. We will not ship awards.** Ribbons will be awarded through 6th place. HorseSpot.net will be tracking results and rankings as the shows take place!

Photographers: Lauren Aston Photography will be covering arenas for competition photos. Online galleries are available to view and purchase your winning moments.

Sponsorships: Expanded Awards in this division are all thanks to local support and sponsorships. Sponsor forms are available on the NM State Fair website. Arena Banner sponsorships are also available to show your support for this great event and get your business in front of a major public audience!

Gate Calls: The two-minute gate will be enforced. The gate will close two minutes after the first horse enters the ring or in cases with large classes taking more than two minutes, after the entry of the final horse in a continuous string of horses. If tack changes are necessary, it is the exhibitor's responsibility to notify the gate person and request a three-minute gate hold. Note: Due to unforeseeable problems with the mechanical devices, the paddock and barn calls over the PA system are considered COURTESY. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate at the prescribed time.

Refusal of Entry/Protest: All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike like conduct, intoxication, and animal cruelty.

Horse Show Breed Specific Rules

Arabian/AQHA Western Dressage

Registration: A horse must be entered in the name of his registered owner(s) only and must be entered under its full registered name. All Breed Horses do not require memberships or registration papers.

Half-Arabians and Anglo-Arabians: Horses shown in this section must have been issued a certificate of registration from the International Arabian Horse Association or the Arabian Horse Association or the Canadian Partbred Arabian Register as a Half-Arabian or Anglo-Arabian, **or if under one year of age, be eligible for registry and registration applied for and must be entered under their full registered name.**

Fees: Open checks are required upon check-in. Full payment by check, credit card is due at check-out of show. Class Fees on Entry Form. Concurrent Main Ring classes have double judge and AHA fees.

Dressage & Western Dressage: Membership IS NOT required for all showing in Dressage and Western Dressage for classes held Sunday September 7th as part of the Arabian Show with All Breed Exhibition Classes. AQHA Western Dressage recognition can be added to any of the offered Western Dressage classes and ridden once to earn points. Entries close August 27th and will not be accepted as post entries. AHA Membership Required: For Arabian recognized classes only. If you do not have a current AHA membership you must pay the AHA single event member fee or purchase annual membership. Exhibitors showing in Amateur Owner classes must be listed

as an owner of the horse on the registration papers of the horse they are exhibiting. All entries must be made in writing on an official entry form for this show. Every owner, trainer, rider, driver, handler and parent or guardian of a junior exhibitor must sign the entry form waivers and must be an AHA Competition Member or pay the nonmember/single event fees. A horse must be entered in the name of his recorded owner. The complete address and phone number of the recorded owner must be given, even if an agent enters the horse. All horses belonging to one owner must be entered on one entry form. No horses may be entered on more than one form.

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. This horse show is conducted in accordance with the Rules of the United States Equestrian Federation, Arabian Horse Division. The official Rule Book of USEF will prevail for this show. This premium list is based on the rules of the current Rule Book. Any changes or corrections of rules will automatically become a part of this premium list. Each participant in the show is responsible for knowledge of and is subject to the USEF Rules. The Show Manager shall decide on questions not covered by USEF rules and their decisions will be final. This is an Arabian Value Show, not recognized by USEF. However, the rules pertaining to the Arabian division will be adhered to for this horse show.

AHA MEMBERSHIP STATEMENT: EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS.

AHA REQUIREMENTS:

- A)** All exhibitors entered in this event must be a current AHA member with a competition card, join AHA at the show, or pay a Single Event Membership fee of \$35.00 per person. This includes any owner, trainer, driver, rider, or halter handler who exhibits horses in the show ring or signs the entry form as the responsible person for any individual's horse. A photocopy of your AHA membership card must accompany your entry.
- B)** AHA Membership affidavits are no longer available. If you do not have your AHA card you must pay the single event Member fee.
- C)** There is an AHA mandatory fee of \$20.00 per horse/Judge. (\$10 AHA judges' commission and education/evaluation, Resolution 9-90 and \$10 AHA per horse fee).

All Breed Exhibition Classes held within the Arabian show are considered "training" classes and human training equipment will be allowed. Show clothes not required. Two hands may be used with any bridle. These classes DO NOT count towards the NM State Fair Overall All Breed Awards.

DRESSAGE CLASSES: FOR DRESSAGE/WESTERN DRESSAGE—**POST ENTRIES WILL NOT BE ACCEPTED** After **08/27/28***** Dressage classes may not run in order listed in the schedule. AHA and AQHA recognition for Western Dressage only. All Classical Dressage is "schooling" and unrecognized. Maximum of 50 rides available – Maximum of three (3) rides per horse/day. Dressage entries must be mailed or e-mailed and postmarked or e-mail time will determine order of entry. No hand carried entries accepted. Ride Times will be available on the Expo NM website and on Facebook page. We will not contact exhibitors unless there is a conflict. AQHA classes may run concurrently. This means one test ridden can count for

more than one point recognition, with payment for each class desired in pre-entry. AQHA riders will be responsible for indicating which test and division (Open, Amateur and Youth) they want AQHA recognition for and an individual entry fee will be required for each recognition.

DEFINITIONS: The following abbreviations, as defined, will be used to describe class specifications:

IOTR/IOTD — Junior Owner to Ride/Junior Owner to Drive.

AOTR/AOTD — Amateur Owner to Ride/Amateur Owner to Drive.

ITR/ITD — Junior Exhibitor to Ride/Junior Exhibitor to Drive.

ATR/ATD/AATR — Amateur to Ride/Amateur to Drive/Adult Amateur to Ride.

SELECT — AOT, AAOT, AT, AAT, IOT, IT — Refer to USEF AR113.1f

All-Breed /Exhibition Classes/Training Tack: DO NOT require AHA Membership or Registration Papers to participate. Membership or non-member fee will apply. Membership allows points from these classes to count towards AHANM high point awards. All-Breed (AB) classes are Open to ANY BREED. Martingales, hackamores, humane training devices and two hands are allowed in ALL AB classes. Show clothes and equipment are not necessary but may be worn in All Breed classes.

Amateur — Every Adult rider having reached his/her 19th birthday prior to 12/1 of the previous year must have an amateur card issued by USEF.

Amateur owners –Leased horses are not eligible for amateur owner classes. Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF GR122. The sale of a horse does not eliminate this requirement. (Contracts of Sale or Bill of Sale will not be accepted.)

A/HA/AA Walk Trot 10 & Under Classes: Open to riders 10 & Under as of 12/01/2023. Please provide rider's DOB. No stallions allowed in Walk/Trot 10/Under division classes.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of New Mexico State Fair, dba Expo NM ("Expo") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in both sanctioned/non-sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities of the Equine Events ("Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement ("Agreement"):

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of Expo as published in the Premium Book and on the website at www.statefair.exponm.com, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").
