Entries: Pre-entry closing date is August 20, 2025. All entries will be online at www.NMStateFair.Horsespot.net
There are no post entry fees for online entries. Payment by check or credit card will not be required until check-in. Pre-entries are encouraged for expedited gate admissions and preferred stabling assignments. Cattle, Dressage and Western Dressage will require entries by Closing date of August 20, 2025. All Entries pay Office fee per Exhibitor/Horse as designated by each show's specified rules and entry requirements. Pre-ordered shavings by closing date will be at your stalls on arrival. Entry confirmation will be sent to email on entry form for initial gate 6 access at move-in. PRE-ENTRIES online are ENCOURAGED!

No need to print entry form. Any signature pages can be completed at check-in. All entry requirements can be done with the new online platform!

Payment: Checks payable to EXPO NM or valid credit card required upon show completion. You may send entry by email without payment to the secretary or go completely through the online entry platform with Horse Spot.net. You do not need to use a credit card to confirm your online entry! To obtain back number, each horse will need to submit health certificate (dated within 30 days), leave an open check or credit card form, and liability waiver for all participants. Adult signature is required for minors. Bad checks and declined credit cards incur \$50/occurrence fee.

Check-In: All entries will be assigned stall or designated parking for trailer-in when they enter Gate 6. There is a Horse Hut office attendant that will greet you and show you your stall area. Please be prepared with your confirmation of entry and health papers to proceed to unload. When your horses are settled, the office in the indoor horse complex will check you in. Please refer to the NMLB website for further requirements by state. On Site/post entries are accepted for all shows EXCEPT Cattle, Dressage, and Western Dressage.

Check-Out: Health papers will be returned upon closing of account and proper payment completed at the end of the show. Gate 6 Horse Hut attendants will verify your health papers upon departure. The health and safety of your horses is our top priority, and these requirements will be enforced.

Office: Will be open 1 hour before the start of the competition daily and stay open at least 1 hour after final class. Check-in for groups of 6 or more are advised to contact the secretary for a time slot. Please call 505-803-3228.

Scratched/Added classes: Entries will only be charged for classes they participate in and may add or scratch during the show through the HorseSpot.net platform with no penalty.

Feed & Bedding: Shavings and feed may be pre-ordered on entry form for \$11/bag. Orders for shavings can be added to your pre-entry or purchased through the show office or HorseSpot.net. No outside shavings are allowed without veterinary certification of medical need.

Arenas: Indoor arena 117' x 250'. Outdoor arenas 125; x 264'. Footing is sandy loam in all arenas.

Stall Assignments: Pre-entered horses may request stall areas. We cannot guarantee those stalls will be available. Groups of horses or trainers should submit entries together to be stabled in a group with stall reservation form. Stalls may be occupied after 5pm the night before the event and must be vacated at the end of the day of show entered. 1 Horse Stall for one day is included for each entry. Only one animal per stall. Tack rooms must be added to a horse's entry to reserve at the rate of \$25/night or day and not included with \$30 base office fee. The stall chart will be available at the Gate 6 entry Horse Hut. **NEW MEXICO STATE FAIRGROUNDS IS NOT RESPONSIBLE FOR ANY ITEMS LEFT UNATTENDED.**

Parking: Designated unloading zones have a 45-minute limit. There is no parking in barn aisles or leaving trailers unhooked for any reason. Vehicle parking for exhibitors will be available, on a limited basis, in the Gate 6 area with parking pass. Each

Horse entered will include 1 parking pass and 2 admission tickets. Any additional parking passes and/or admissions passes will need to be purchased at the horse show office during check-in. Support vehicles during set up will need to purchase additional passes for show days. The entry for horse trailers and exhibitors is Gate 6 at the northwest corner of the grounds. This is south of Lomas on the east side on San Pedro (across from McDonald's). Gate 6 is open from 6am to 9pm daily. After hours arrivals/departures use Gate 3, which is further south on San Pedro at the Copper stop light.

Trailer Parking: There is no on-site (unhooked) trailer parking. The armory located at 600 Wyoming Blvd., Albuquerque, NM 87123 is a secure site for trailers to be unhooked while you show. Parking in the lot at gate 6 is for passenger vehicles only. You may obtain parking passes for the off-site parking at the horse show office. Maps are available at show office. Limited parking is available for day trip haul-in for shows in the far East Roping arena.

Prize List Corrections/Changes: The NM state Fair reserves to itself the final and absolute right to interpret these Competition Requirements, to fairly and impartially settle, determine all matters, questions and differences in regard thereto, or otherwise arising out of or connected with or incident to the Show, and the right to amend or add to these Competition Requirements as its judgments may determine. The NM State Fair reserves the right to cancel events or change scheduling if determined necessary. See each division for any specific or special Competition Requirements.

Dogs: No dogs are allowed in competition arenas or warm-up areas.

Motorized Vehicles: No golf carts or private motorized vehicles are allowed.

Protective Headgear: Any Exhibitor may wear protective headgear in any division or class without penalty from the judge. USEF strongly encourages all Exhibitors to wear protective headgear. It is the responsibility of the Exhibitor, parent, guardian, or trainer of the junior exhibitor to see that the headgear worn complies with safety standards and is properly fitted and in good condition.

Prize Money & Awards: Payouts will be issued to the exhibitor of the class within 30 days. W-9 and full account payment required for all entries. Buckles/Awards will be awarded onsite at the conclusion of each show. Winners must pick up all awards or they will be forfeited and awarded to the next eligible winner. We will not ship awards. Ribbons will be awarded through 6th place. HorseSpot.net will be tracking results and rankings as the shows take place!

Photographers: Lauren Aston Photography will be covering arenas for competition photos. Online galleries are available to view and purchase your winning moments.

Sponsorships: Expanded Awards in this division are all thanks to local support and sponsorships. Sponsor forms are available on the NM State Fair website. Arena Banner sponsorships are also available to show your support for this great event and get your business in front of a major public audience!

Gate Calls: The two-minute gate will be enforced. The gate will close two minutes after the first horse enters the ring or in cases with large classes taking more than two minutes, after the entry of the final horse in a continuous string of horses. If tack changes are necessary, it is the exhibitor's responsibility to notify the gate person and request a three-minute gate hold. Note: Due to unforeseeable problems with the mechanical devices, the paddock and barn calls over the PA system are considered COURTESY. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate at the prescribed time.

Refusal of Entry/Protest: All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike like conduct, intoxication, and animal cruelty.

Management also reserves the right to refuse any entries. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise. Entries Open July 1 2025. Close August 20, 2025.

PRIZE LIST CHANGES AND/OR CORRECTIONS: Changes and/or corrections to the Premium, if any, will be posted on the NM State Fair website at www.statefair.exponm.com and Facebook page "NM State Fair Horseshows 2025."

REFUSAL OF ENTRIES/PROTESTS: The show Management will be governed by USEF rules with respect to refusal of entries. All decisions made by the Judge and/or Show Management are final and cannot be protested. **Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike like conduct and animal cruelty.**

USEF SAFE SPORT TRAINING REQUIREMENT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org. If you are a USEF Competing Member 18 years of age or older you are required to complete the core Safe Sport Training within 7 days of activating your membership. If you do not complete the training, you are ineligible to participate in all USEF activities including competitions. TAKE the SAFE SPORT TRAINING at USEF.org by logging into your member dashboard.

Each competitor is responsible for supplying the show management with the correct and required association numbers of AHANM, USDF and/or USEF for the horse, owner, rider, coaches, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not count towards regional or national awards. The proof of these numbers must be in the form of either their actual membership/registration cards or a facsimile of them. Proof of membership must be included with entry form. Failure to provide proof of USDF membership will result in competitor being charged USDF non-member fees. Members that are unable to produce the USDF memberships cards/registrations or a facsimile will be asked to sign an affidavit and pay an affidavit fee. EFFECTIVE 12/1/22: To be eligible to compete at Federation Licensed Competitions, coaches, trainers, and legal guardians signing as coaches or trainers on behalf of their minors must be Senior Active Members in good standing, Riders and owners are eligible for one (and ONLY one) Show Pass per year. Trainers and coaches are no longer eligible to participate under a Show Pass.

All entries are taken on a first come, first served basis. Show may return late arriving entries after the show is filled, or place entries on a wait list on an as-received basis. Send in the entries or complete online at **www.nmstatefair.horsespot.net** as soon as possible to assure entry to the show. **Only one horse-rider combination per entry form.** No exhibitor may withdraw horses from a licensed show after it has commenced, or remove them from the show grounds without permission of the show secretary.

All Equine Canada competitors with a current Equine Canada membership must also have a complimentary USEF membership. If you Equine Canada membership is current for the show year, then the USEF membership will be No Charge. This rule change pertains to all Canadian riders & owners. Please see membership details at usef.org. You will also need a USDF membership, or a Non-Member Fee (\$55) will apply to each rider/owner.

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULEBOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

ENTRIES: Accepted electronically on a first come, first served basis, based solely on the priority of receipt of entries electronically per GR906.1, based on online email system electronic time stamp or postmark. Once the competition is filled a wait list will be established and it will be based on priority of receipt electronically. Wait list will be maintained through August 20th, 2025. Post entries (time stamped after closing date) will be not be accepted. NO EXCEPTIONS. Proof of memberships and horse registrations must be included with entry. ALL COMPETITORS MUST SUBMIT WITH THEIR ENTRY CURRENT PROOF (WITHIN 6 MONTHS OF THE FIRST DAY YOUR HORSE ENTERS THE COMPETITION GROUNDS) OF EQUINE INFLUENZA AND RHINOPNEUMONITIS VACCINATION FOR ALL HORSES 7 MONTHS OF AGE OR OLDER. A CURRENT COGGINS WITHIN 12 MONTHS MUST ALSO BE SUBMITTED. If entry is incomplete, horse/rider combination will be placed on the wait list until required paperwork is received. Emailed and online entries are preferred.

Times: provisional times available at www.statefair.exponm.com and Facebook page "NM State Fair Horseshows 2025." Official times will be posted at the show office by Noon the day before the start of each show. Numbers required all times when horse is outside of stall or not tied to a trailer. Entry required if schooling only

(schooling fee and appropriate stabling fee required). Anyone not appearing for any of their dressage tests without prior notification to the show secretary will be "scratched" from their remaining classes. Those rides will be filled if possible. Credit Cards: VISA, MasterCard, American Express, & Discover will be accepted during the shows.

Freestyle entries: Freestyles must be provided to show management on a CD, thumb drive or sent digitally with your entry as an MP3 file. Sound checks will be performed Saturday evening and during available breaks as needed. If you cannot make Saturday evening, you must set up an appointment with the announcer for an additional time.

MATERIALE CLASSES Judged under saddle as a group at walk, trot and canter according to criteria listed on the "USDF Materiale Class" score sheet. Horses must be at least 36 months of age to participate.

REFUNDS: All Cancellations must be made in writing either by email, fax or mail. Up through closing date, all fees refunded except office fee. From day after closing to day prior to competition, class fees will be refunded only if ride(s) can be filled from wait list. Qualifying fees and drug fees (if horse is not on show grounds) refunded. Qualifying fees also refunded if scratched before ride and requested to be refunded, otherwise forwarded to USDF or applied to other indebtedness. During competition days **no refunds including for Acts of God. Office fee is never refundable.**

ARENAS: Indoor Horse Arena sandy loam footing. Outdoor warm-up arenas; all sand mix footing. Arenas watered and worked throughout show. **Show arenas open for schooling Saturday after 4pm and throughout show after classes are complete until show office closes.** Schooling at the end of the show days is dependent on weather conditions and timing of the show hours. Lunging in designated arenas only.

AWARDS: Ribbons through 6th place. There will be no awards ceremonies, so participation is not required. **Winners must pick up all awards or they will be forfeited and awarded to the next eligible winner. We will not ship awards.** Ribbons will be awarded through 6th place. Horse Spot will be tracking results and rankings as the shows take place! High Score Coolers for Open, AA and Jr/YR. Jackpot payback will be 80% of entry money to winner.

STABLING: Permanent 10×10 stalls with dutch doors, permanent 10×10 stalls with barred full doors. Shavings required but not provided. Shavings available on grounds, place orders in show office and on show entry form. **Stabling available at 9am on Friday August 29, 2025. Early arrival available.**

NON-COMPETING HORSES: Must submit completed and signed Entry form to the Show Secretary, show proof of current Coggins, and pay N/C Horse fee plus Office fee. Grounds or stabling fees are also required. USEF/USDF fees or Late fee NOT required.

SHARPS CONTAINERS: are located throughout the barns and one is also available in the show office. Please use them appropriately or fines will be assessed per USEF guidelines. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.

EMT: Event EMS - On site 45 minutes before start of show through completion of all classes.

CONCESSIONS: Food available on premises. Hours will be 1 hour before the start of the show until the completion of the show day. Many restaurants located in the area of the facility.

HOTELS: Host Hotel Hampton Inn – 505-837-9300; 2300 Carlisle NE, Albuquerque. Horse show exhibitor special rate of \$91/night. Reserve lodging early to get the best rates and availability.

SHOW OFFICE: final hours will be posted outside the office on Friday August 29th, 2025. but these are anticipated hours: 7am-6pm daily or until 1 hour after classes are completed.

DOGS: MUST BE ON LEASHES AT ALL TIMES WHILE ON SHOW GROUNDS (including in stable areas). Owner will be fined – first offense \$50, second offense \$100, third offense will result in the owner's dismissal from show grounds. All pets must be leashed. Non-compliance may result in USEF penalties.

Camping/RV Reservations – No RV hook-up options during NM State Fair.

OTHER:

- All emergency numbers will be posted in/outside the Secretary's office and in the barns.
- Hand walking will be permitted around the outside of the show rings each morning until 20 minutes prior to the start of each show day.
- Riders may substitute horses once they have entered only upon presentation of a Vet Certificate for the incapacitated horse, or a bill-of-sale, and only in classes in which the first horse was entered. The Secretary must be notified 24 hours before the class(es) take(s) place, and a new entry form must be completed.
- In accordance with GR1301.7-8: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events.
- For current Great American/USDF Championship requirements, go to www.usdf.org/competitions/competitions-championships/regionals/index.asp
- Under New Mexico law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities.

USEF SafeSport Requirements

- The required SafeSport Training is on the U.S. Center for SafeSport website and is free for USEF members.
- All USEF Competing Members (18 and older) are required to complete SafeSport Training within the first 7 days of joining or renewing USEF membership.
- The SafeSport Training requirement applies to all USEF Competing Senior Members even if competing in classes (such as USDF Intro or USEF Opportunity) where USEF membership is not required.
- Junior Members (under 18 years) are not required to complete SafeSport Training at this time.
- Any individual signing an entry blank as Trainer or Coach, must have completed the Safe Sport Training prior to the first day of competition.
- If SafeSport Training is not completed within 7 days of joining or renewing membership, and a completion certificate (for all three phases) presented to the show secretary on or before the first day of competition, the entry will NOT be allowed to compete.

- If SafeSport Training is not completed by USEF members and certificates provided to the show secretary on or before the first day of competition, there will be NO REFUNDS for entries. This applies to all USEF members (riders, owners, trainers or coaches) for any entry, including those classes where USEF membership is not required.
- Participants (riders, owners, trainers, coaches) who are NOT USEF members are not required to complete SafeSport Training.
- If SafeSport Training is overdue and certificates are not presented to the show secretary, or posted yet on the USEF website, the entry (horse and competitor) will be allowed to remain on the competition grounds but cannot compete.
- Competitions are required to check the USEF SafeSport Ineligibility list after entries are submitted and up to the first day of competition. Competitions that allow ineligible participants to compete are subject to penalties by USEF.

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

Protective HEADGEAR RULE FOR DRESSAGE

Protective headgear is defined as a riding helmet, which is in compliance with the accepted testing standards published on the Federation's website. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including noncompeting riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. The harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place. Protective headgear may be the same as or a coordinating color with the coat, and may include contrast coloring, accent, and crystal decoration.

Membership Statement:

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

Prizes and Payout: High Score Coolers for Open, AA and Jr/YR. Jackpot payback will be 80% of entry money to winner.

2025 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2025 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
 A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or
Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF
membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF.
For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both
USEF and USDF.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. The minimum percentages are as follows:

ATTENTION DRESSAGE EXHIBITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

This competition is recognized by USDF for 2025

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
 sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
 Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
 exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
 academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

B.
